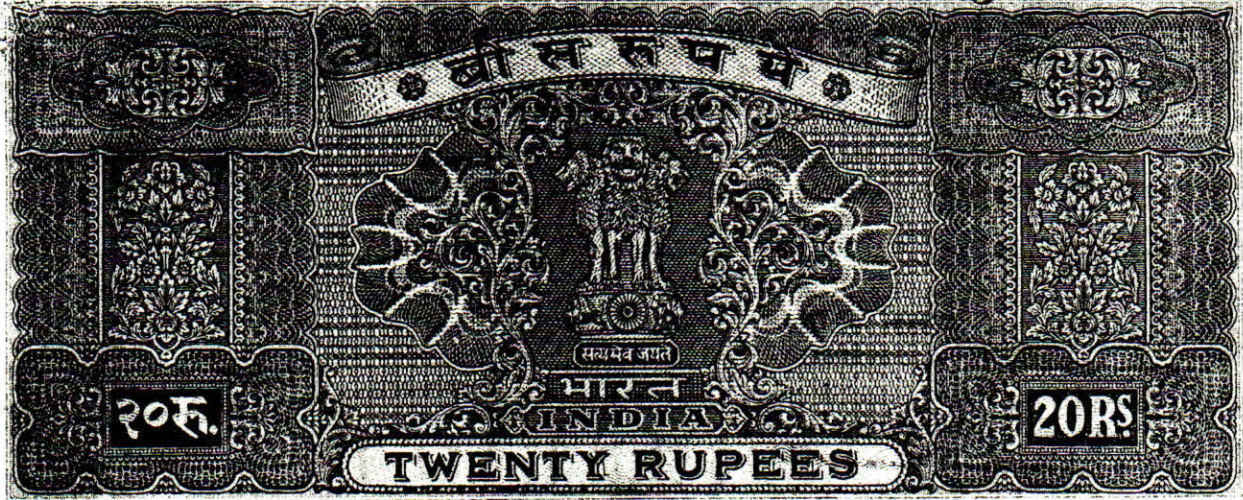

AND WHEREAS the said sum of Rs.505/- (Rupees five hundred and five only) being pay order No. 005589 dated 12.10.1991 ~~for~~ drawn on ALLAHABAD Bank, as T. Nagar, Madras 17. 'INITIAL CORPUS' for the said Trust paid and handed over to the Trustees before execution of This Deed, which the Trustees also have acknowledged and admit;

WHEREAS for the purpose of proper carrying out objectives of the Trust, the Authors of the Trust had decided to reduce the terms of the said Trust to writing:

NOW THE DEED OF PUBLIC CHARITABLE TRUST WITNESSETH AS FOLLOWS:-

1. The Trust shall be a Public Charitable Trust with the object of starting, running, maintaining and taking over educational and vocational institutions as the Trustees might decide from time to time.
2. The name of the Trust shall be VIVEKANANDA EDUCATIONAL TRUST. The Registered office of the Trust shall be for the present at D.19, Shreyas, 45, Vijaya Raghava Road, T.Nagar, Madras-600 017 and shall function at such premises as may be arranged and notified by the Trustees from time to time.

4. The objects for which the Trust is established are:-

- b) To establish, maintain and manage Schools, Colleges and other Educational Institutions both residential and non-residential and libraries for the advancement of knowledge in any subject of language.

- g) To establish, maintain and manage boarding houses or hostels for students studying in Schools, Colleges or other Educational Institutions including Technical Training Institutions.
- h) To promote Research for the advancement of Science and Technology.
- i) To promote ethical, moral and human values in society through the medium of Education.

- j) To produce, print, publish, circulate and distribute Books, Periodicals, Journals, Pamphlets and other materials for advancing the cause of Education.
- k) To provide necessary forum and other necessary facilities for holding public lectures, Seminars and Discussions on matters connected with Education.
- l) To accept on such terms and conditions as may be decided by the Trustees from time to time donations, subscriptions, aids and contributions from any Government, Local authority, Corporation, firm, Company, Syndicate, Association or other persons or from any Charitable or other Institutions, whether they be in cash or in the form of other movable and immovable property for the purposes and objectives of the Trust.
- m) To acquire by purchase, gift, settlement, Will or otherwise any property whether movable or immovable or to acquire any right for the purpose of the Trust.
- n) To sell, give on lease, mortgage or otherwise transfer any such property or rights vested in the Trust as the Trustees may unanimously decide from time to time by 3/4th majority.

- o) To construct, maintain or alter any building or undertake allied works necessary to carry out the object and purpose of the Trust.
- p) To sell, improve, manage, develop, exchange, lease or let under lease or sublet, mortgage, dispose of, turn into account or otherwise deal with all, any or any part of the property of the Trust as the Trustees may decide from time to time.
- q) To invest, and deal with all the moneys of the Trust not immediately required in "Specified Investments" as per provisions of Sec.13(1)(d) read with Sec.11(5) of the Income Tax Act 1961 as amended from time to time.
- r) To borrow money for the purposes of the Trust with or without security from Banks, Financial Institutions and others and also to offer as Security any moveable or immovable property or other funds or properties of the Trust.
- s) To take over the establishment, maintenance and management of any Institution of the type that the Trustees may decide from time to time if it is necessary in the interest of the Trust to take over such Institutions.

- t) To start educational institutions for imparting formal and nonformal education to the public in general and to the rural masses and people residing in underdeveloped areas in particular.
- u) To establish and run hostels for students, to promote, conduct or patronise all activities of educational character for the benefit and utility of the General public especially to the underprivileged class of Society.
- v) To inform and instruct children and youth of the history and culture of Bharat by publishing and distributing free of cost or at concessional prices, books, booklets, cartoons and other reading materials including newspapers, journals and magazines containing the lives and works of great saints, seers, social workers, artists, painters, musicians, writers and others who have contributed to the development of the qualities of truth, valour, brotherhood and other enlightening qualities and have fought against various social evils, and promoted peace and harmony.

- x) To run and maintain libraries and other allied institutions for the furtherance of the above objects for the benefit of all persons belonging to whatever community irrespective of caste, creed or religion.
- y) To support and render financial assistance to charitable and educational causes and institutions, Trusts or societies by means of donations, loans, grants on such terms and conditions as the Trustees deem fit and proper, which in the opinion of the Trustees would carry out all or any objects of the Trust.
- z) To support, fund, finance or otherwise reward or help any individual or group of individuals who have dedicated or wish to dedicate themselves for the benefit of this Trust.
- aa) To award scholarships to students and such other individuals who have devoted themselves to the various public causes in line with the objects of the Trust.

seminars, lectures, debates, meetings or any other similar activity to promote the above objects.

- ac) To promote sports, athletics, discipline among youth by promoting physical education and training by various means including supply of sports materials, uniform and other articles and things necessary for the purpose.
- ad) To purchase, construct or otherwise acquire and hold properties including land and buildings for the purpose of the Trust.
- ae) To donate or transfer to any Trust or other corporate bodies registered under the Tamilnadu Societies Registration Act or any Institution that the Trustees may consider from time to time.
- af) To do all or any other thing as may be conducive to or necessary for the advancement of the above objects.
- ag) To do all such things as are incidental and conducive, to the attainment of the aforesaid objects.

5. This Trust is a Public Charitable Trust the benefits of which shall ensure to the public without distinction of caste, creed, religion etc.,

6. The affairs of the Trust shall be managed by the Trustees for the time being and the Trustees are hereby empowered to form as many committees as they like including a managing committee for the day-to-day running of the Trust.

7. The Trust shall be irrevocable.

8. The funds and ~~ex~~ income of the Trust shall be solely utilised towards the achievement of the objects and no portion of it shall be utilised for payment to Trustees by way of profit, interest, dividends, salary, remuneration except out of pocket expenses incurred by them in the course of discharging their responsibilities as Trustees.

9. A Trustee shall cease to held the office:

- 1) On his death
- 2) On his resignation.
- 3) On the Trustee becoming a lunatic or insane person or becoming insolvent.

10. The affairs of the Trust shall be so carried on that the dignity of the individual and brotherhood of all people are recognised that the Schools and other Institutions opened by it are made available to all sections of the people.

11. The Trustees may formulate such Rules and Regulations as are necessary for the convenient and proper running of the Institutions and the Trust.

12. The Trustees shall among themselves elect a President, a Vice President, a Treasurer, a Secretary, a Joint Secretary and shall formulate the necessary Regulations in relation to the duties of each one of the office bearers of the Trust.


13. The Trustees for the time being are entitled to co-opt such Trustees as they deem it necessary for the proper running of the Institutions.

14. The total number of Trustees for the time being shall be five and it shall be open to the Trustees from time to time to increase the number of Trustees as the Trustees may decide.


15. In case of any vacancy among the Trustees being occasioned by death, resignation or incapacity of any Trustee or otherwise the Trustees shall be entitled to co-opt in such vacancy any Trustee or Trustees.

16. The Trustees shall not be entitled to any remuneration for the services rendered and if the Trustees so decide the Trustees in respect of meetings held outside their respective residence, all conveyance may be paid.

17. With a view to carrying out the objects of the Trust hereinabove mentioned and to manage and administer the Trust funds and without prejudice to the generality of any powers hereby or by law

conferred or implied or vested in the Board of Trustees, the Board of Trustees shall continue to have following powers:

- a) To apply and use the funds for all or any of the objects of the Trust and/or accumulate the surplus unapplied portion of income and invest the same, subject to the provisions of the Income-tax Act, 1961, as amended from time to time, relating to accumulation of income and investment thereof. The funds of the Trust shall be invested in the modes specified under the provisions of the Income-tax Act, 1961 governing charitable Trusts and the Indian Trust Act.
- b) To receive any money or other assets in any shape or ~~forms~~ forms as gift or donation and to hold the same as Capital Fund and/or apply it for furthering the objects.
- c) To invest the funds from time to time in such manner as may be permitted under the provisions of Income-tax Act and to dispose of, alter or vary the investments from time to time to realise the investments.
- d) To compromise, compound, abandon, submit to arbitration or otherwise institute any actions,



suits, proceedings, claims or other things, whatsoever, arising out of the administration of the Trust Fund, and to enter into, give execute and do such agreements, instruments and composition or arrangements, releases, and other things, as may seem expedient, without being liable or responsible for any loss occasioned by any act or things so done by them in good faith.

- e) To acquire or to dispose of through mortgage, hire, lease or otherwise moveable or immovable, tangible or intangible properties, and rights and benefits and to manage the same.
- f) To receive, collect or realise or cause collection or realisation of all income that accrue or become due on all or any investments and to grant receipts and discharges.
- g) To represent the Trust in all Courts (Original and Appellate) or before judicial or quasi-judicial authorities and other authorities, departments of Government, Semi-Government or local authority.
- h) To sign and verify all pleadings, memoranda of appeal, petitions and applications of all kinds, and to engage lawyers and other professionals and to take all such other necessary steps.

The Trustees are authorised to open account or accounts with any bank and operate the said accounts jointly or otherwise by one or more amongst themselves as they deem fit and proper.

18. The official year of the Trust shall be from 1st April to 31st March.

19.(a) The quorum for the meeting shall be three or 1/3rd of the total number of Trustees whichever is greater.

(b) All decisions of the Board of Trustees shall be taken by a majority vote. In the case of equality of votes, the Chairman of the meeting may exercise a casting vote.

(c) It shall be open to the Board of Trustees to adopt any resolution by circulating the same among the Trustees, provided such a resolution is attended to by a majority of the Trustees. All resolutions adopted by circulation shall be placed in the immediately next meeting of the Board of Trustees for recording the same.


20. The Trustees shall meet as often as the circumstances require to transact the business of the Trust. There shall at least be two meetings of the Trustees in a year.

21. All legal proceedings by or against the Trust shall be instituted in the name of the Trust through its President.

22. Every Trustee and the Secretary of the Trust shall be indemnified from out of the funds of the Trust

against all loss or expenses incurred in the discharge of his duties, except such as has happened through his wilful negligence or dishonesty.

23. The Trustees shall have the power to alter or amend the provisions of this Deed of Trust, provided that such alteration or amendment shall not be inconsistent with the objects of this Trust as well as the provisions of the Income-tax Act, 1961 governing the Charitable Trusts, provided further that the amendments shall not be given effect to, unless approved by the Commissioner of Income-tax.

24. It is hereby declared that the Hon'ble Secretary and any one Trustee duly authorised by the Board of Trustees shall have power to execute any document required to be registered under the law and it is further declared that such document shall be deemed to have been properly executed by the Trust.

25. It is hereby declared that the Trustees have power to wind up the Trust by merging or amalgamating with another Trust, Charitable Society having similar objects and enjoying recognition by the Commissioner of Income-tax under Section 80-G of the Income-tax Act, 1961
